John O'Dowd heads the LLM General programme in UCD Sutherland School of Law. He has been a lecturer in law in UCD since 1991. His areas of teaching include contract law, constitutional Law, administrative Law, media Law and the law of the European Convention on Human Rights. His research has focused most recently on the collective organisation of the judiciary as a professional interest group and its implications for the separation of powers. He also has a keen interest in constitutional law in India and his academic career has taken him to the University of Oxford (Wolfson College). He is an active member of the UCD Centre for Constitutional Studies and is a regular speaker at the centre's public events.

Applicant Profile

- This programme is intended for applicants with a Law degree, or an interdisciplinary degree in which law was a major component. An upper second class honours, or international equivalent is required.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 and 6.5 in reading and writing), or equivalent.
